necessary to enable them to function as units of self-government ” .

Corruption in Decentralised Governance: A case study of K ...

In the paper, decentralization is defined as the empowerment of local governments, (not as decision making at sub-national levels as other literature on the subject have done). Corruption is seen as “ the abuse of public office for private gain or exercise of official powers against public interest. ”

The Impact of Decentralization on Corruption ...

The relationship between decentralization and poor governance also depends on how subnational expenditures are financed—the higher the share of nontax revenues in total revenues as well as grants and transfers from higher levels of government in total expenditure, the stronger the association between decentralization and corruption.
