Inductive approach, also known in inductive reasoning, starts with the observations and theories are proposed towards the end of the research process as a result of observations.. Inductive research "involves the search for pattern from observation and the development of explanations – theories – for those patterns through series of hypotheses".

Inductive Approach (Inductive Reasoning) - Research ...

The inductive approach involves beginning with a set of empirical observations, seeking patterns in those observations, and then theorizing about those patterns. The deductive approach involves beginning with a theory, developing hypotheses from that theory, and then collecting and analyzing data to test those hypotheses.

Deduction starts out with a generalization that follows a process to reach a specific, logical conclusion. Induction is the opposite - making a generalization from a set of specific observations.

In logic, we often refer to the two broad methods of reasoning as the deductive and inductive approaches. Deductive reasoning works from the more general to the more specific. Sometimes this is informally called a "top-down" approach. We might begin with thinking up a theory about our topic of interest. We then narrow that down into more specific hypotheses that we can test.

Induction: this is the process by which we draw a general conclusion from individual instances or observations. The benefits of an inductive approach, as seen for example in grounded theory, are that it allows flexibility, attends closely to context and supports the generation of new theory [see the paper on social loss as example].
